Establishment of new Commission - envisaged endorsement of Strategic Plan



Main priority Green deal

- The Green Deal is a wide-ranging programme designed to address climate issues. It has three axes:
- Mobilisation of at least €1 trillion of sustainable investment over the next ten years. for climate and environmental action, while attracting private funding, notably through the key role to be played by the European Investment Bank.
- Incentives and redirection of public and private investment, notably by promoting green budgeting and green public procurement and by developing solutions to facilitate the approval of state aid for regions engaged in just transition.
- Practical support by helping public authorities and project promoters to plan, design and implement sustainable projects.

Digital transformation and Outreach

- Further development and enhancement of the Funding and Tenders Portal:
 - Improve functionalities & searchability,
 - One stop shop for Horizon Europe and other centrally managed programmes

Promote outreach and stakeholder engagement as a continues process

- Continue organisation of outreach events and trainings in the Member States in liaison with NCPs
- Organise tailored events and info-days such as the Co-ordinator's day using new technologies to multiply impact



Model Grant Agreement

New MGA developed in a corporate context:

- One model for all centrally managed programmes
- With specificities for Horizon Europe regarding the Rules for Participation
- Drastic reduction of number of models and alignment of provisions

Simplification in terms of funding:

- Personnel costs: unique simpler corporate mandatory formula to calculate actual personnel costs => No time sheets
- Project based remuneration: similar rules as in H2020 with further simplification
- Further deployment of simplified forms of funding (e.g.: unit costs and lump sums)

A more user-friendly MGA:

Inclusion of a quick-glance data-sheet for a given project, with information about payments, reporting and
